DOB 4-19-57 - RM 207 "HEART OF CHAR." 1024 CLEVELAND ST. SHE ADVISED THAT SHE WAS LEGALLY RESPONSIBLE FOR SUBJECT AND WAS HIS GUARDIAN. WRITER ASKED FOR PROOF AND SHE WAS UNABLE TO PROVIDE IT, INSTEAD SHE ADMITTED SHE HAD NO PAPERS MAKING HER HIS GUARDIAN. Writer met with Sgt McAuley on friday 10-28-83 and he explained the case to writer . Writer reviewed the case and found that HRS was not contacted by the original officer and that the welfare of the victim and his brothers was in question .

On 10-28-83 1630 hrs writer contacted HRS and they stated that Pam Groves or Cindy Hess would be out in the North County -area this night and that they would stop by the station and speak to writer and investigate the case . Writer filed a dependency petition and a copy of the case for HRS . HRS workeers did not come to the station on 10-28-83 .

Writer called HRS on 10-29-83 and spoke to Cindy Hess and she advised that she would be out to CPD to pick up the paperwork and investigate the case . Writer was on the road when Cindy came to the station and picked UP the paperwork at 2015 hrs .

On 10-30-83 writer contacted Cindy Hess at HRS and she, advised that she and Bill Muldanado had gone to the 1024 Cleveland address and attempted to make contact with the children listed in the petition .

Cindy states that everyone gave her a difficult time and refused to answer questions about the children Continued

Cindy states that her partner Bill is able to read lips and observed some "legal person " who apparently had some authority tell the nanny Deborah Koval not to give HRS any information and further to advise that the children were back with the mother . Cindy states that they could not produce any logs , papers or documentation of any kind on the children . Cindy further states that the people around the office appeared very nervous and she believes that the children are still in town somewhere .

Cindy states that she observed children working in a garbage area of the establishment and that she has real concerns on what is happening to the children . Cindy believes that HRS could obtain a court order to Hook into the welfare of the children . Cindy is going to refer the case to the daytime supervisor and attempt to contact the mother in California .

Writer suggests that HRS be contacted in the daytime and that a court order is obtained so that they may check the welfare of the children . Writer has spoken to Det Goatcher in the past and he stated that he had found that the establishment has several day care centers and that he could not find up to date paperwork on the children in daycare .
