SUBJECT: CULT ATTEMPTS TO CONTROL CITY ELECTION

TO : CITIZENS OF CLEARWATER

PUBLICLY ANNOUNCED REPORTS BY THE SCIENTOLOGISTS TO INFLUENCE THE FEBRUARY 12th CITY ELECTION PROVE THAT THE CULT INTENDS TO WIN POLITICAL CONTROL OF OUR CITY.
