NARRATIVE

SYNOPSIS OF EVENT:

Sometime between 0200 hours on 032797 and 2015 hours on 032797? at 320 Island Way #104? Carrie Slaughterbeck passed away- Her boyfriend? Alan Green was out of town between those above dates and times and no one had heard from Slaughterbeck.

SOURCE OF ACTIVITY:

Dispatched to 320 Island Way #104 for a possible homicide.

INVESTIGATIONS:

When I arrived on scene the Paramedics vehicle was parked out front and the door to the residence was open.

I entered the residence going up the stairs to the second floor. There I found Paramedic Gary Costa and Alan Green. Costa advised that the deceased was on the next floor. Ofc. Johnson went upstairs and I stayed with Alan Green. Everything in the house appeared to be in order. There did not appear to be any signs of a struggle or other criminal activity.

I asked Green what his relationship to the deceased was and he replied he was engaged to her.

Green provided me with Carrie Slaughterbeck's date of birth and a phone number for her parents that live in Indiana. He also said that she was not under treatment for any illness although she has had bulimia for 10 years. Ofc. Johnson advised what he had found upstairs (see Ofc. Johnson's supplement) and we determined that the death may be suspicious.

We had the paramedics and Green leave the residence? treating the residence as a crime scene and started a Crime Scene Entry Log.

NARRATIVE

I spoke with LePrevost and she advised that she pronounced Slaughterbeck deceased at 2026 hours.

I continued to interview Green who was visibly upset. He stated that he has known Slaughterbeck for nine years. She has seen doctors in the past for her bulimia but has not for over two years. Instead she has been in a "program". I asked for the name of the program but he would not answer. I then asked Green if there was a doctor or counselor in charge of the program so that we could check on Slaughterbeck's health. Green answered that the program she was on was devised by themselves. The two decided what foods she was to eat and so on.

I questioned Green as to when the last time he saw Slaughterbeck alive. Green gave the following account:

He left on 032697 at 1400 hours to go to Orlando for a presentation on a subject he and Slaughterbeck were writing a book on. He drove his vehicle and was to return the same night. When he went to return home around midnight his vehicle broke down along 1-4. He walked to a phone and called Lorraine Evans. Evans is an associate of Green who was at the presentation also. Evans came to pick up Green on 1-4 around 0100 hours and they went back to her house in Orlando where Green spent the night. Green called Slaughterbeck at around 0200 hours on 032797 and told her what had happened. Slaughterbeck did not seem depressed nor did she complain to Green about anything.

In the morning he called and had his car towed to be worked on. Green again tried to call the victim at 0815 hours on 032797 but received no answer. He also tried to call the Clearwater Police to do a welfare check on Slaughterbeck at around 1200 hours today but the officers checked the outside and found nothing out of the ordinary.

The garage where he had his car towed told Green his motor was seized. Green decided to take a bus back and returned home around 2030 hours this date when he found Slaughterbeck.

I asked Green if Slaughterbeck was also a writer. Green said that Slaughterbeck was helping him write the book and sometimes spent eighteen hours a day at the computer.

Green would not say who or what he was writing the book on.

Green could not tell me where along 1-4 his car broke down nor could he provide the name of the garage that towed/ worked on his vehicle.

I questioned Green where the presentation was he attended and he could only say a restaurant in Orlando and did not know the name.

I asked Green for Evans address and phone number but he could only provide her phone number. He would not say who she worked for only that she was an associate of the person he was writing the book on.

Green said that Slaughterbeck had not been depressed or upset lately nor has she told him she wanted to harm herself.

I questioned Green if Slaughterbeck knew who Evans was. Green stated that Slaughterbeck knew he was going to the presentation to meet with Evans in reference to the book-

I advised Sgt. Zegzdryn and Det. Halloway of the information I had obtained and Det. Halloway took over the investigation.

Ofc. Johnson and myself stood by for crowd control and to canvass the neighborhood per the detectives.

I assisted with canvassing building #1 and 3.

NARRATIVE

Source/Background:

Dispatched on 03-27-97 at approximately 2020 hours to 320 Island Way\* unit #104\* reference a death investigation.

Investigation:

Upon arrival I was directed to the north bedroom on the third floor of the three floor townhouse by Clearwater Fire Department EMT Costa. Upon arrival in the north bedroom on the third floor\* I observed Clearwater Fire Department paramedic Leprevost checking the decease\* Slaughterbeck for vital signs. I observed the following: the bedroom was located on the north side of the third floor. The head of a queen size bed was against the east wall and a dresser was against the west wall. A tv stand and tv were position at the foot of the bed. Slaughterbeck was laying on her right side between the south wall and the bed. Slaughterbeck's head was pointing west and feet pointing east. Slaughterbeck's arms were folded across her chest area and she was covered with a bedspread from mid-chest to her feet. Slaughterbeck had a long thin raised red mark across her forehead. The mark was approximately 1/8" to 1/4" wide and 6 to 7 inches long. Slaughterbeck had some slight discoloring in the lower part of her right side where her blood had began pooling below the skin.

Leprevost advised me that Slaughterbeck had no vital signs and asked me if she should run an EKG strip. I advised Leprevost that due to the fact that Slaughterbeck had no vital signs and the pooling of blood under the skin had began no EKG strip was nessessary. Both Leprevost and I backed out of the room in order to protect the scene. Leprevost

advised that the only thing she disturbed in the room was that she moved the bedspread from over her head to check for vital signs. Leprevost said that Green told her that he had placed the bedspread over her after he found her.

I advised Sgt. Zegzdryn of the incident and began a crime scene entrance list. At approximately 2040 hours I turned the crime scene entrance list over to Officer Blanco. Upon arrival of Det. Co I Ioway and Det. Greem I advised them of the information I had and walked them thru the scene. At approximately 2112 hours I took over the crime scene entrance list from Officer Blanco. I continued the list? see attached for names. I cleared the scene at 0105 hours.

NARRATIVE: On 3/27/97, at approximately 2020 hours, the Communications Center received a call from the Yellow Cab Company advising that one of their cab drivers had reported a murder at 320 Island Way, #104. Officers responded and found a white female deceased in the condominium at that location. Det. Green and I, who were working 3-11 as night detectives, were also requested to be enroute.

At 2042 hours, Det. Green and I arrived on the scene. FD Rescue 46 was already present and we were advised that paramedics pronounced the victim deceased at 2026 hours. We met with Sgt. Zegzdryn and Ofc. Johnson, who advised that the victim was discovered by her fiancée, **Alan William Green, W/M, DOB 8/22/48, who resided at 320 Island Way, #104, with the victim, Carrie Lynn Slaughterbeck, W/F, DOB 6/1/73.** Green advised that he caught a cab from the Greyhound Bus Station on Gulf To Bay to his condominium. Upon his arrival at the condominium, he went inside and found the victim lying on the floor deceased. He covered her with a blanket and ran back downstairs to the cab, where he asked the cab driver to call the police. I was advised that Ofc. Brems was standing by with Alan Green in the condominium at this time.

Unit #104 is a three-story townhouse condominium with a loft that could be considered a fourth story. Upon our arrival, the front door was open and the rear door was locked. The sliding glass doors on the second and third floors were closed but unlocked. None of the doors had any signs of forced entry. Most of the interior lights were on. The victim was located in what appeared to be the master bedroom

on the third floor between the bed and the south wall. She was lying on her right side in a semi-fetal position with her head in a westerly direction. There were signs of rigor mortis, and there was lividity present consistent with the position she was found in. On her forehead was a large abrasion that appeared to be post-mortem due to the fact there was no blood present. There was a slight abrasion on her left hand and one on each knee, which also appeared to be post-mortem. These abrasions were possibly caused by her falling after her death. There were no signs of petechia in her eyes. Several black ants were crawling on the body.

At this time, I requested that Sgt. Zegzdryn have officers set up a crime scene and cordon off the area with crime scene tape. I then contacted Acting Sgt. Howard, advised him of my observations, and requested assistance with the investigation. He indicated that he would be enroute and asked that I contact Det. Steffens and have him respond. I also contacted PCSO and requested that Forensic Specialists respond to process the scene. I then requested that Ofc. Brems escort the victim's boyfriend, Alan Green, outside of the crime scene area.

After Alan Green was escorted outside, I accompanied him to my detective vehicle to interview him further regarding the incident. I asked that he sign a Consent To Search form allowing us to search his residence, which he did. He then gave the following statement regarding the victim:

Alan last saw the victim on 3/26/97 at approximately 1400 hours when he dropped her off at Publix near their condominium. He was driving the victim's Ford Tempo at that time. After dropping her off at Publix, he went to Orlando, where he met with Jim Pearson and Lorraine Evans at approximately 1600 hours to discuss a book he (Alan) is writing about Jim Pearson's life. After meeting with them, he left Orlando at approximately 2300 hours. While driving back to Clearwater, the Ford Tempo broke down on Interstate 4 approximately ten miles outside of Orlando. He called Lorraine Evans and asked her to pick him up, which she did. He left the Ford

Tempo parked on the side of the road. At approximately 0130- 0200 hours, he called the victim to advise her that the Ford Tempo had broken down and he would not be coming home that night. They talked for approximately ten minutes longer and he said he would call her in the morning. The victim sounded fine at that time and there did not appear to be any problems. At approximately 0815 hours the following morning (3/27/97), he called the victim and there was no answer. He called several times throughout the day until approximately 1200-1300 hours and there was still no answer. At that time, he contacted the police and asked that they check on the victim's welfare. He was later advised that the officers had knocked on the door but no one answered. He then requested that the officers break the door down to make sure the victim was all right and was told that they would not do that. At approximately 1445 hours, he caught a Greyhound bus from Orlando and arrived in Tampa around 1730 hours. He had to wait in Tampa until 1915 hours to get a transfer bus to Clearwater. He arrived at the Greyhound Bus Station in Clearwater at approximately 2000-2010 hours and called Yellow Cab to get a cab to his condominium. He was told that he would have to wait a while for a cab. A few minutes later, he saw a cab pull in front of the bus station and flagged it down. He had the cab driver take him from the bus station to his condominium. Upon their arrival, he told the cab driver he had to go inside to get a check to pay him because he had no cash on him. He used his key to unlock the front door, at which time he went inside and found all of the lights on inside except for the living room light, which he turned on. He went to their bedroom, where he observed the victim lying on the floor covered with black ants. He knocked some of the ants off of her and covered her with a blanket. He then ran downstairs and told the cab driver to call the police.

Det. Green conducted an interview with the cab driver from the Yellow Cab Company. See Det. Green's supplement for further details.

At approximately 2200 hours, PCSO Forensic Supervisor Miller and Forensic Specialist Zordan arrived to take 35mm photographs and videotape the scene.

At approximately 2400 hours, I contacted the Medical Examiner's Office and spoke with Janice. I advised her of the facts and circumstances of the investigation known to this point and requested that they have the removal service respond to transport the body to the Medical Examiner's Office. At approximately 0040 hours (3/28/97), Lucas Semple arrived and removed the body.

At this point, the cause of death had not yet been determined and it was decided that the condominium would be sealed. Alan Green was advised not to go inside until the cause of death had been determined. At approximately 0115 hours (3/28/97), all of the doors were locked and sealed by the Forensic Specialists. We then cleared from the scene and requested extra patrol until we returned.

On 3/28/97, at approximately 0930 hours, I was contacted at home by Acting Sgt. Howard and advised to attend the victim's autopsy on this date. At approximately 1000 hours, I was advised that the Medical Examiner's Office was preparing to start the autopsy.

Upon my arrival at the Medical Examiner's Office, I learned that Dr. Nick Hartshorne would be conducting the autopsy. Det. Steffens contacted PCSO and requested that a Forensic Specialist be present at the Medical Examiner's Office during the autopsy. Forensic Specialist Proveaux subsequently arrived to **take** photographs during the autopsy. The autopsy began at approximately 1100 hours and was concluded **at** approximately 1230 hours. Dr. Hartshorne advised that he believed the cause of death to be mitral valve prolapse, a heart condition associated with sudden death. We had previously been advised by the victim's mother **that** the victim had this heart condition.

At the conclusion of the autopsy, I contacted Alan Green and advised him that we were going to release the condominium to him due to the fact that the preliminary results of the autopsy indicated that the victim's death was due to natural causes. I also contacted the victim's parents and advised them of the preliminary results of the autopsy. They indicated that they were making arrangements to have the victim's body transported to Lafayette, Indiana for funeral services.

**NARRATIVE:**

On 3/27/97, at approximately 2028 hrs. writer received a call from the Comm. Center via radio that they had received a call from Yellow Cab Company advising that one of their cab driver's had reported that one of his patrons had gone into his residence and found his fiance dead. They then requested that I respond to the scene.

Later writer and Det. Calloway responded to said location at approximately 2042 hrs. Upon our arrival, we noticed that the FD was already at the scene. We then met with Sgt. Zegzdryn, who advised that the victim was discovered by her fiance, Alan Green, who is white male, dob 8/22/48, who also resided at the residence. We then went upstairs to where the victim was said to be located and noticed that the victim was lying on the floor in what appeared to be the master bedroom between the bed and the south wall of the far north bedroom on the third floor of the residence. The victim was lying on the right side of her body in a semi-fetal position, with her head facing west. At this point writer also noticed that the victim's body was covered with what appeared to be a bedspread. Writer also noticed that there was a large abrasion on her forehead, but that said abrasion did not appear to have bled.

Det. Calloway continued to look for other signs as to her death (see his supplement). Writer, while looking, was advised by Det. Calloway that there were several ants crawling on the victim's face.

At this time, Det. Calloway requested that Acting Sergeant Howard be called at home. Later he requested that Detectives Howard and Steffens respond to the scene. He also contacted PCSO and requested that they also respond.

Later writer made contact with a Bruce Robert Frye, w/m, dob 3/25/52, who was the driver of the Yellow Cab Company that dropped the subject Alan Green off at his residence. This subject had been detained by Ofc. Weller. Writer conducted an interview with Frye and Frye made the following statements: Frye stated that he is the cab driver of cab #148. He stated that on this date at approximately 1956 hrs. he picked the subject Alan Green from the Greyhound Bus Station on Gulf to Bay. At approximately 2010 hrs., they arrived at Green's residence, at which time Green advised that he didn't have any cash money, that he needed to write him a check. He stated Green got out of the vehicle, walked into his residence, taking his bags inside along with him. Approximately eight to ten minutes later, the subject came out of the residence with a checkbook in his right hand, yelling "my fiance is dead, my fiance is dead". He stated at this time he then called his dispatch. Green then ran back inside, stayed approximately three to four minutes, then he turned wherein he yelled "where's the police?" and then went back inside where he never returned. Frye stated that at this point his boss told him to call "Karen" on the phone at 562-4206. Note that this would be one of the Comm. Center employees. Karen advised that she had units responding to the scene at this time. It should be noted that Frye's cab fee was approximately \$11.90. This investigator then asked Frye did he and the subject Green engage in any other conversation. He stated that while en route to Green's

residence, he stated that Green advised him that his fiance's vehicle had blown an engine on 1-4 while en route back to his residence and that it would cost him two or three thousand dollars to get it fixed. He said that he then called a friend where he stayed overnight with that subject, name unknown at this time. He stated that sometime this date in the morning hours, that he had said vehicle towed to a Texaco station. When asked did he know what type vehicle, he stated that Green advised him that it was a \*93 Tempo. Frye stated that he continued to engage the subject in conversation. Green told him that his fiance was still making payments on the vehicle. He then told Green that he had better get the engine fixed or that he would be making payments on a piece of junk. Green then told him that he had been on the bus since approximately 1400 hrs. this date riding the bus from Orlando to Clearwater.

Later writer spoke to a subject Kim Bright Cassano, w/f, dob 11/26/54, who advised that she was a friend of the subject, Alan Green. Cassano stated that on this date sometime between the hours of 2025 and 2030 hrs., she received a call from one of the paramedics who stated that Mr. Green wanted her to come over because there was an emergency at the residence, and that he wanted to tell her in person. He then came to the telephone and said "Carrie's dead". She then asked him "do you want me to come over", he advised "yes". She told him that she'd be right over. I then asked Cassano how long has she known the couple. She said approximately a year, and that both Alan and Carrie did odd jobs for her. When asked what type jobs, she stated that Alan and her were working on writing a book and that Alan and Carrie worked from their home gathering information from the Internet. When asked what was the name of the business, she said "Kim Incorporated". She gave an address of 639 Cleveland Street, work phone number being 442-5454. I then asked her when was the last time she saw Carrie, she stated approximately two weeks ago when she

picked up her paycheck. Then I asked her whether or not Alan said anything about going to Orlando. She stated yes, she stated that on 3/26/97 at approximately 1600 hrs., Alan was supposed to meet with a white female named Lorraine at her residence for a meeting. Said meeting was supposed to take place from approximately 1600 to 1800 hrs. this date at Lorraine's residence. From there he and Lorraine were to go to another meeting from 1800 hrs. to 1900 hrs. and meet with a subject named Jim Pearson, a subject whom the book was to be written about. I then asked her whether or not she knew what type of car they owned, she stated a white car. She also stated Alan made mention that Carrie's car had broken down somewhere on 14 and that he called Lorraine to pick him up. Cassano stated that her address was 162 Wood Creek Drive in Safety Harbor, phone #724-1003, and that she was the owner of the 639 Cleveland Street along with her husband.

Later writer and the other investigative detectives, along with patrol officers did a canvas of the neighborhood. Writer then went to apartment 101 but made no contact with subjects living there. I then went to apartment #102 where I made contact with a white male, Michael L. Pawelek, dob 3/30/50, who gave the address of living on Torrey Drive in Hamberg, New York 14075, phone #716/648-2928. Pawelek stated that on this date at approximately 0700 hrs. he took his uncle to an eye clinic. He stated that they returned around 0900 hrs. He stayed home for a few minutes. At approximately 1200 hrs. he was out in the garage area working on his Volvo at which time he heard loud noise, stepped outside and saw a large white passenger van backing up towards room #104. By the time he came out of the garage, subjects in the van took off. He stated at this point he noticed that the van was a large passenger-type van that appeared to have a logo on the side with the word "Clearwater" and other unknown words with 8" letters that spanned about four to five inches in width. He stated that he observed a passenger, a white male that had on a

beige baseball cap turned backwards, but did not see the driver. Writer advised Det. Calloway of same, noting that the subject did not know exactly what the loud noise was, but that it sounded as if the van had hit something or that a door could have slammed shut. Pawelek advised that the residence that he was staying in belonged to his uncle, Frank Hollins and that he would be in Clearwater approximately two weeks if we needed any other information.

I then knocked on room 103, made contact with white male, Dennis Lynch, dob 9/2/43, who had just arrived in Clearwater one to two hours prior to units arriving at the scene. Lynch stated that he did not see anything or hear anything. He stated that the residence was owned by a friend of his named Richard Brown, who lived in New Jersey. He gave his last known address as 5 Chawmont Drive in Williamsville, New York 14221. Area code 716/626-5687. He advised that he would be here until Tuesday, 4/1/97.

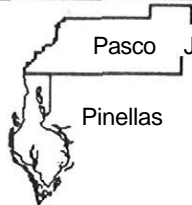

**PROTOCOL**

**EXTERNAL EXAMINATION:** The body is clothed in the following articles of clothing. A black appropriately fastened bra. A long sleeve blue turtleneck pullover shirt and lastly a pair of blue and green checkered cotton panties. The body is that of an emaciated Caucasian female, 69 inches in length weighing 101 pounds and appearing slightly older than the stated age of 23 years. The body is cold and has been refrigerated. Rigidity is three plus in the upper, lower extremities and jaw. Lividity is developed over the posterior right lateral dependent body surfaces, is dark pink-purple and fixed, as well as being noted over the right side of the face and neck. There is no evidence of embalming. Examination of the head reveals evidence of injury to be described in further detail below. The head hair is dark brown, wavy, has a normal distribution and measures up to approximately 13-1/2 inches in length. The eyebrows and eyelashes are dark brown, full and otherwise unremarkable. The eyelashes are coated with a small amount of mascara. There is a small amount of cosmetic makeup noted over the upper eyelids. The irides are brown. The left sclerae is slightly injected and the right sclerae is markedly injected demonstrating a horizontal linear region of congestion consistent with the junction of upper and lower eyelids (tache noire). The conjunctiva are congested, more so on the right. The nasal spine palpates to be intact. The lips demonstrate some early drying artifact as does the tip of the tongue. The ears are symmetrically positioned and aside from prominent cyanosis of the right ear are otherwise unremarkable. The right earlobe contains three cosmetic perforations. The left earlobe contains two cosmetic perforation. The neck is symmetrical and the trachea is palpable in the midline. The upper chest is flat, the breasts are small, and demonstrate no obvious palpable masses. The abdomen is scaphoid and there is a 3-1/2 inch region of light green skin discoloration noted over the right lower abdomen consistent with early decompositional change. The upper extremities lie in a symmetrical fashion and are without evidence of acute injury. There is prominent muscle atrophy of the biceps and forearms. The hands contain five digits bilaterally. The fingers demonstrate similar muscle atrophy. The fingernails are neatly trimmed and overhang the finger tips by up 1/16 inch. The fingernail beds are markedly cyanotic. The external genitalia are that of an adult female. Speculum examination of the vaginal vault reveals a non-soiled white tampon within the vaginal vault. The perineum is unremarkable. The lower extremities lie in a symmetrical fashion and are without evidence of acute injury. The lower extremities demonstrates similar muscle atrophy as noted over the upper extremities. The soles of the feet are unremarkable. The toenails are regularly trimmed and flush with the toe tips. The toenail beds are mildly cyanotic. The back and perineum are unremarkable.

**EXTERNAL BODY MARKINGS:** Located over the left and right lateral abdomen, several parallel up to 2 inch obliquely oriented linear striae-type stretch marks. Located 3 inches inferior to the left patella a 1/4 inch geographic well healed scar.

**EXTERNAL EVIDENCE OF INJURY:** Located over the right forehead centered 2

inches inferior to the vertex of the head, 3/4 inch right of midline additionally centered 2 inches directly superior to the medial aspect of the right eyebrow a 5/8 inch by 3/8 inch dark red rectangular horizontally oriented abrasion. Located over the left forehead 1-3/4 inches inferior to the vertex of the head, 5/8 inch left of midline additionally centered 3 inches directly superior to the left medial canthus a horizontally oriented crescent-shaped 1-1/4 X 1/3 inch dark red abrasion. Both above described abrasions run in a discontinuous linear fashion. Located over the right chin, 8 inches inferior to the vertex of the head, 1/2 inch right of midline a 1/8 inch dark red-brown abrasion. Located over the region of the left patella 20 inches superior to the pedal surface of the left foot an oval shaped 1/2 inch orange-yellow postmortem-type abrasion. Located over the left medial thigh, 25 inches superior to the pedal surface of the left foot a faint 1/2 inch region of green-yellow ecchymoses. Located 2 inches lateral to the left patella, 19-1/2 inches superior to the pedal surface of the left foot a 1/2 inch green-yellow region of ecchymoses. 2-1/2 inches superior to which is a faint 1/2 inch similar green-yellow region of ecchymoses. Located over the dorsal surface of the left foot 6 inches proximal to the tip of the left greater toe are five punctate 1/16 inch red abrasions surrounded by up to 1/32 inch regions of erythematous skin discoloration. Crawling across the dorsum of the left foot are several small black ants. Located 2 inches inferior to the right patella, 17-3/4 inches superior to the pedal surface of the right foot an oval 1/2 inch red-orange abrasion.

INTERNAL EVIDENCE OF INJURY: Right frontal acute subgaleal hemorrhage 1/3 inch

### INTERNAL EXAMINATION:

HEAD: Reflection of the scalp reveals a focal region of acute subgaleal hemorrhage as previously described. Otherwise the scalp demonstrates the usual scattered reflection petechiae. The calvarium is intact. Removal of the calvarium in the usual fashion shows the epidural space to be normal. Likewise no collections of subdural blood are present. The brain is removed in the usual manner and weighs 1260 grams. The leptomeninges are smooth and glistening and the gyri demonstrate their usual orientation and configuration. The vessels at the base of the brain are normally disposed and no anomalies are identified. Serial sections of the brain reveal the cerebral cortical ribbon to be intact. The usual anatomic landmarks of the cerebrum, midbrain, cerebellum, pons and medulla demonstrate no abnormalities. The first portion of the spinal cord viewed at the level of the foramen magnum is unremarkable.

NECK: A layered dissection of the soft tissues, muscular and bony structures of the neck demonstrate mild congestion of the right lateral neck strap muscles, however, no obvious intramusculature hemorrhage is identified. Otherwise the usual anatomic landmarks are unremarkable.

BODY CAVITIES: The body cavities are opened in the usual manner. The pleural

and peritoneal surfaces are smooth and glistening. The apical surfaces of the left upper lobe are remarkable for scattered tan-yellow easily lysed fibrous adhesions. The mediastinum and retroperitoneum show the usual anatomical features. The leaves of the diaphragm are intact. There is no internal evidence of injury.

CARDIOVASCULAR SYSTEM: The heart weighs 250 grams. Examination of the epicardium reveals a conspicuous absence of epicardial fat. The chambers demonstrate their usual shape and configuration with no gross hypertrophy. The coronary arteries are normally disposed, follow a right dominant pattern and are remarkable for only scattered atherosclerotic streaks present throughout the course of all three vessels. The cut surfaces of the myocardium reveal no evidence of thickening. The aortic tricuspid and pulmonic valves are unremarkable. The mitral valve is remarkable for interchordal ballooning of the leaflets which prolapse posteriorly into the left atrium. Prolapsing is more prominent along the anterior leaflet, however is also present along the posterior leaflet. Several of the chordae attached to the anteriorly leaflet are elongated there is no evidence of recent rupture. There is no commissural fusion. Both anterior and posterior valve leaflets demonstrate focal fibrotic thickening. In addition, there are scattered delicate fibrous deposits noted on the endocardial left ventricular surface. The endocardium underlying the posteriorly leaflet is remarkable for a 1/8 inch fibrotic nodule. The aorta follows its usual course and the origin of the major vessels are normally disposed and unremarkable. The great vessels of the venous return are in their usual positions and unremarkable.

RESPIRATORY SYSTEM: The larynx and trachea are unremarkable and are continuous in the usual fashion with the primary bronchi. The secondary and tertiary bronchi are unremarkable. The congested right lung weighs 550 grams. The left lung weighs 375 grams. The pleural surfaces are smooth and glistening. The cut surfaces reveal a congested edematous pink-red parenchyma with no evidence of natural disease or injury. There is no consolidation or enlargement of the air spaces. The pulmonary vessels are normally disposed and unremarkable.

HEPATOBIILIARY SYSTEM: The liver weighs 1340 grams and has a smooth glistening surface. The cut surfaces show a deep red-brown cut surface. The gallbladder contains approximately 7 cc of bile. The biliary tree is unremarkable.

LYMPHORETICULAR SYSTEM: The spleen weighs 190 grams and has a smooth glistening capsule and an unremarkable congested parenchyma with the usual anatomical features. The thymus is involuted and replaced by fat. The lymph nodes were noted show no pathologic change.

URINARY SYSTEM: The right and left kidneys weigh 95 grams each respectively. The cortical surfaces are smooth and glistening with good preservation of the cortex and good corticomedullary differentiation. The pelves show their usual anatomic landmarks and are continuous into normal appearing ureters which insert into an

unremarkable bladder containing 75 cc of amber colored urine.

GASTROINTESTINAL SYSTEM: The pharynx and esophagus are unremarkable. The contracted tube-like stomach contains approximately 3 cc of yellow-orange mucoid material. The mucosal lining of the stomach is intact and demonstrates the normal rugal folds. The small intestine contains similar orange-yellow-brown viscid fluid. The distal large intestine contains soft brown stool. Both the small and large intestines are unremarkable and the appendix is present.

GENITOURINARY SYSTEM: The uterus occupies its usual position. Serial sections of which reveal a 1 mm in thickness beefy red succulent endometrium. The adnexa lie in their usual positions and are unremarkable.

ENDOCRINE SYSTEM: The thyroid, adrenals and pancreas are unremarkable.

MUSCULOSKELETAL SYSTEM: The musculature is normally developed and the bony structures demonstrate their usual relationships. The abdominal fat measures 1/4 inch at the level of the umbilicus.

### MICROSCOPIC

ORAL. ANAL AND VAGINAL SWABS: No spermatozoa identified.

SPLEEN: Congestion.

KIDNEY: No specific pathologic abnormality.

ADRENAL GLANDS: No specific pathologic abnormality.

MITRAL VALVE : Prominent degeneration and attenuation of the zona fibrosa with concomitant compensatory thickening of the spongiosa layer.

HEART (Left Ventricle): Prominent endocardial fibrotic thickening of the left ventricular endocardial surface with small fibrotic protruding nodule, focal myxomatous change, patchy interstitial fibrosis.

LIVER: Intense congestion, numerous pigment laden hepatocytes.

LUNG: Atelectasis, congestion and proliferation of intra-alveolar pigment laden macrophages.

BRAIN: Neurons and white matter without significant pathologic abnormality.

CORONARY ARTERY: Minimal intimal thickening.
