SITUATION: Clearwater Florida, Mayor Cazares is still in office and in position to attack us and has given no indication of letting up on the attack

WHY: Cazares has not seen the light and ceased his suppressive actions.

HANDLED: (Cp) by Base submitted to US for OK. In addition, the Attorney that Cazares is employing for his law suit against against the Church (Pat Doherty) has dropped the Cazares case. It is quite likely that Cazares will be hiring an attorney to our liking for his law suit against the Church. Finally a B1 estimate on a future possible Cazares attack in response to a 10^{AM} letter for libel which Legal Base was sending was done up in time to be able to prepare PR with the data. PR handling resulted in our line getting to the newspaper before the Cazares attack was launched. This took place last week.
