DECLARATION OF SAMUEL D. ROSEN IN SUPPORT OF MOTION FOR ATTORNEYS' FEES AND EXPENSES

I, SAMUEL D. ROSEN, hereby declare the following to be true and accurate under pain and penalty of perjury:

- 1. I am a partner in the law firm of Paul Hastings Janofsky & Walker, LLP ("Paul Hastings"). I have personal knowledge of the facts set forth below, and if called upon to do so, could and would competently testify thereto.
- 2. I received a Bachelor of Arts degree in Philosophy from Boston University in 1966, a J.D. degree, cum laude, from Suffolk University Law School in 1969 (where I was graduated first in my class), and an L.L.M. degree from New York University Law School in 1971. From 1977 to 1992, I was a partner in the firm of Milgrim, Thomajan & Lee. In 1992, I and approximately 24 other attorneys from that firm, including name partners Roger Milgrim and Alfred Lee, joined Paul Hastings. I have served as Vice-Chair of the Paul, Hastings Litigation Department and have served as the senior partner in our firm's New York-based litigation practice group.

- 3. In the 33 years I have been privileged to practice law, first as a trial attorney for the federal government (1969-1971) and in private practice, I have been lead counsel in hundreds of cases.
- 4. I was admitted to the Bar of the State of New York in 1969 and have been a member thereof in good standing continuously. I was admitted to the Southern and Eastern Districts of New York in 1971, and the Second Circuit Court of Appeals in 1975. I am also admitted to, and have had the privilege of representing clients before, the Courts of Appeal for the First, Third, Fourth, Fifth, Seventh, Eighth, Ninth, Eleventh, and the Federal Circuits. I have been a member of the bar of the Fifth Circuit Court of Appeals for 20 years and have argued several cases there.
- 5. By virtue of *pro hac vice* admissions, I have represented clients in over fifty (50)

  U.S. District Courts and Divisions, including every District Court in the State of Texas. I have argued cases in the Northern, Southern, and Western Districts of Texas. I am and have long been a member of various bar associations including the ABA and the New York State Bar Association. I have long served as a member of the Editorial Board of the law review-style publication, The Trademark Reporter®. I have also served as a member of the Suffolk Law School Dean's Committee on Curriculum. I have been written up in several magazines legal and general circulation on several of my cases. I have published several articles. An article of mine was cited as authoritative in a decision by the U.S. Supreme Court.
- 6. Reflective of my experience as a litigator, I was selected ten (10) years ago by the Board of Judges of the Eastern District of New York federal court as one of the charter *pro bono* arbitrators in that Court's mandatory arbitration program. Similarly, in 1995, I was selected by the Board of Judges of the Southern District of New York federal court as one of the charter

mediators in that Court's mandatory mediation program. Further, in a trademark/antitrust case styled, "Lloyd's of London v. Lloyd's U.S.," former Attorney General of Texas, Waggoner Carr, was appointed special master by the Western District of Texas to oversee pretrial proceedings. At the end of the case, Attorney General Carr told the Court (Judge Nowlin) in my presence that he had never before seen the quality of briefing that he received from me.

- 7. My firm was engaged to assist plaintiff Religious Technology Center ("RTC") prior to the commencement of this litigation, and counsel from my firm have participated extensively in every phase of this litigation.
- 8. The expertise of the associates from my firm who worked on this case are comparable, albeit given their lesser years of experience.
- 9. The attorneys and paralegals of my firm who worked on this case and their applicable hourly rates are below. The hours each expended in this case are shown in our firm's billing statements annexed hereto as Exhibit A (in order to avoid any question on this motion, I have also attached here the underlying time records as Exhibit B), with certain charges eliminated that are not properly recoverable as a fee in this case. Each attorney kept contemporaneous records of hours, which were then input into a computer:

Samuel D. Rosen, hourly rate of \$550 in 2000, \$575 in 2001 and 2002. Kimberly J. Koerner, hourly rate of \$390.00 in 2001 and \$400.00 in 2002. Romy E. Berk, hourly rate of \$320. Timothy D. Lynch, hourly rate of \$205.

10. On this application, RTC seeks counsel fees for services performed by my firm through March 13, 2002 in the amount of \$174,652.75, as of 2/28/02. This amount does not include time I spent as a trial witness both in preparation of my testimony on January 23, 2002 and at trial on January 24, 2002 and January 25, 2002. Specifically, one-third of my time for

those three days has been allocated towards counsel time and two-thirds of my time for those three days has been allocated to witness time. This adjustment has been made because during certain periods of time on those days, I acted as trial counsel and during other periods as a trial witness. Accordingly, RTC has adjusted the fee part of its application to seek only those attorneys' fees incurred for time I spent as trial counsel as opposed to a trial witness, and consequently has subtracted \$3,067.00, \$3,450.00, and \$6,133.00 from the fee portion of our request for January 23, January 24, and January 25, respectively. The total amount thus subtracted from the fee portion of the application is \$12,650.00 ( - \$80 for two days of witness fees being included in cost bill), but this amount appears in the witness cost portion of the application.

- 11. On its application, RTC also seeks reimbursement of \$32,100.50 for expenses and disbursements made by my firm while acting as trial counsel in the instant action and posted in my firm's books as of February 28, 2002.
- 12. The Paul Hasting's billing statements and time sheets attached as Exhibits A & B reflect only those fees and expenses incurred by my firm which were posted through February 28, 2002.
- 13. Although no bill has yet been generated or tendered to RTC for my firm's post-February 28, 2002 services, the records of my firm reflect the following time billed to this matter after that date, all of which will, in due course, be billed to RTC:

- 14. The fees being requested are at reasonable rates for attorneys having the level of experience and professionalism of the members of our litigation team and are the usual and customary fees billed to all of our firm's clients for our comparable services. Respecting the expenses and disbursements incurred by my firm and billed to RTC, they are all reasonable, necessary and consistent in both kind and amount with those my firm regularly and customarily bills to our clients.
- 15. Respecting the reasonableness of our firm's hourly rates for the services of myself and the other attorneys who worked on this case, once a year we review and adjust hourly rates based upon what similarly experienced and credentialed attorneys charge in New York and elsewhere. Thus, while our New York rates are somewhat higher than those of our counterparts in other areas, excluding the New York geographic component which reflects a higher cost of living and of doing business, I believe that the hourly rates of myself and the others from my firm
