2	OPENING STATEMENT
3	BY MS. WRONKIEWICZ
4	Thank you, Judge. Good afternoon. The
5	individuals who own or rent property have certain
6	rights in that property. One of those rights is to
7	restrict access to their property from people who
8	are not welcome there and that's what this whole
9	case is about.
10	The facts of this case are actually very
11	simple and the evidence will show that on January 25
12	of the year 2000, Mark Bunker, the Defendant, was
13	not welcome at the Church of Scientology.
14	You will hear from Mary Anne Ahmad who
15	will tell you that she works for the Church of
16	Scientology and she will tell you that the property
17	located at 3011 North Lincoln is occupied by the
18	Church of Scientology. She will also tell you that
19	Mark Bunker wasn't welcome there.
20	Well, on January 25, he showed up there
21	anyway and he was met in the doorway by two off-duty
22	Chicago police officers and he tried to walk in to
23	the property. Well, these two police officers told

him, you are not welcome here. You have to leave.

And did he leave? No. So they had to

tell him again. You have to leave. You are not

welcome at this property. Once again the Defendant

did not leave. So, finally, a third time the

Defendant was told he was not welcome there and yet

again he did not leave that property.

So at that point after refusing yet again to not leave the property, he was placed under arrest. And you will hear from those police officers tomorrow.

You will also hear that the Defendant did not arrive at the Church of Scientology alone. He carried with him a huge video camera and while the Defendant was not cooperating with the police officers, when they told him he had to leave, the video camera fell to the ground and into the street.

So these off-duty police officers will tell you that they called for back-up and they placed the Defendant under arrest and then they went to go look for his video camera and they found his video camera in the hands of an individual named William Zizic and they asked Mr. Zizic for the video camera. He didn't want to give it up. In fact, the officers will tell you they actually had to take the

- 1 camera from Mr. Zizic.
- 2 However, based on the testimony that you
- 3 are going to hear from the police officers, the off-
- 4 duty police officers in this case, my partner and I
- 5 are very confident that you will find the Defendant
- 6 guilty of criminal trespass to real property to
- 7 criminal trespass to land because once Mark Bunker
- 8 was told by the off-duty police officers that he had
- 9 to leave and he refused to leave, he committed a
- 10 crime and those police officers acting as agents of
- 11 the Church had a right to tell him to leave and we
- are confident that you will find the Defendant
- 13 quilty. Thank you.
- 14 THE COURT: You may proceed.
- 15 OPENING STATEMENT
- 16 BY MR. de VLAMING
- 17 Members of the jury, Mark Bunker is on
- 18 trial today for criminal trespass. What you are
- going to learn from the evidence of this case is Mr.
- 20 Bunker is from the State of Florida. He was
- 21 contacted by two individuals, both of which are
- 22 dentists in our town, named Dr. William Zizic and
- 23 Dr. Barbara Zizic.
- They were members of the Church of

- 1 Scientology. They were trying for over a year to
- 2 get back \$100,000 that they had given to the Church
- for courses. They were unsuccessful in getting
- 4 their money back.
- 5 They contacted a group that Mr. Bunker
- 6 belongs to in an effort to help them get their money
- 7 back so they can leave the Church of Scientology.
- 8 They contacted Mr. Bunker and asked him to come into
- 9 town because he is a videographer for an
- 10 organization in Florida. He is a producer of
- 11 documentaries.
- 12 You will see the video camera used in
- 13 this case because it has a great deal of relevance.
- 14 It's one of those large video camera made by the
- 15 Sony Corporation for filming documentaries. In
- other words, it's not a little camcorder. It's one
- of those you mount on your shoulder.
- When he came into town, he was given a
- 19 briefing by the Zizics and they asked him if he, Mr.
- 20 Bunker, would please accompany them to the Church of
- 21 Scientology because they were going to discuss the
- return of that hundred-thousand dollars. She wanted
- 23 to have him present so that he could document what
- 24 was being said, what was being discussed, so that

- things would go smoothly.
- When they arrived at the Church on the
- 3 25th of January, what happened was they parked their
- 4 vehicle and they were coming around the side of the
- 5 sidewalk area. What you are going to see is this is
- 6 a photograph of the area and you will find that they
- 7 were coming down this way, if you can see that.
- 8 They were coming down this way walking on the middle
- 9 of the sidewalk.
- 10 What you are going to learn is that Dr.
- 11 William Zizic was first -- I won't say first in
- 12 line. He was the first one. His wife was behind
- him, Barbara Zizic and Mark Bunker with a video
- 14 camera perched on his shoulder was the third one in

Mr. Bunker then knows that the film is rolling and what you are going to see tomorrow when we give a demonstration to you is there is a little red light on the front of the camera when you hit

- the record button. The red light comes on. Very
- 2 significant in this case.
- 3 Mr. Bunker then wants the camera to
- 4 continue rolling. He has no idea who is on top of
- 5 him, no idea who is grabbing him and he pulls the
- 6 camera around so they can't get a hold of the
- 7 camera. He knows it has to keep rolling or he wants
- 8 it to keep rolling.
- 9 Finally, one of the officers grabs his
- 10 thumb, pulls it down. Mr. Bunker puts the camera
- 11 down. It's either that or drop it. The officer
- pulls his thumb back and he let's go of the camera.
- Within 10, 15 seconds, Dr. William Zizic
- 14 who will testify as well as Dr. Barbara Zizic
- 15 watching the whole thing will testify what happened
- 16 and where it happened. Dr. Zizic then picks up the
- 17 camera and aims it and aims it right at the police
- 18 and aims it at what they are doing to him, captures
- 19 the arrest on there, captures the comments.
- 20 Dr. Barbara Zizic is saying, who are
- 21 you? What are you? They say, we are Chicago
- 22 police. She says, show me some ID. The one officer

- given the opportunity to leave. He was grabbed
- 14 immediately because the Church of Scientology knew
- 15 why Mark Bunker was there. They knew he was there
- to help those people get back that hundred-thousand
- dollars and by arresting him, it didn't happen that
- 18 day and that's the evidence in this case. Thank
