- f) The background history of their parents with special interest as to where the family was from in mexico, and when they came to the US, and who in the family was born in the US.
- E) Whether or not Gabe was fired from Merrill, Lynch, Pierce, Fenner and Smith, or what exact circumstances did he leave under.
- h) The name of Gabe's first wife, maiden name and present name, where divorced from Gabe, when, and why.
- 1) Any other contrary data which may turn up during the interviews or investigations of the family.

14. Obtain the marriage records for Gabe Cozares to Elaine Cazares in San Intonio, Texas in 1944. Then check for the civorce records for the same people in Abilene, Texas in approx. 1950. Obtain and keep abreast of all Financial disclosure forms, forms for the disbursement of his campaign collected funds, a list of all campaign contributors, and any other required documentation which Cazares must fill out for his campaign. Insure that he keeps within the letter of the law regarding the running of his campaign. Cam

19. Check the list of campaign contributors to Gazare's election campaign against the list of entheta writers. Turn common names over to PR.

.20. If possible, obtain a copy of Cazares military records from the depository in STL. If this is no longer possible, disregard, as legal will be requesting these on legal limes.

21. Determine the political backgrounds and affiliations of all of Cazare's campaign staff, political backers, and financial contributors. What is being looked for here is any people with commie, or heavy leftist backgrounds, or with backgrounds which if exposed will discredit Cazares in his efforts.


THE FLAG

22. Obtain Fla laws on what constitutes a conflict of interest in the post of Mayor. Then go thru the clubs, groups, and orgs list which Gabe is affiliated with or belongs to. Determine which, if any, of these groups have had dealings with the City of CW since Gabe got into office. Then determine if any of these dealings with the city can be construed as a possible conflict of interest.

DIE BR I & COLL OFF FLAG

23. Obtain the marriage records for Maggie Hughes to Sam Mulligan in Alamogordo, New Mexico in approx. 1931-32, and the divorce records for same people in El Paso in approx. 1932-35. Get details of this divorce as Maggie never lived with this man and the marriage may have been annulled.

24. Obtain the marriage records for Maggie in 1935-37 to Walter Lewis in El Paso. Also obtain her divorse records from Lewis in 1943-44 in El Paso, Texas.

SE DIR SEC & AG I A:

25. Do a full time track on Cazares with the data already on hand, including the data on Maggie Cazares, and from her deposition. This should be done as a first action.

COLL OFF FLAG

26. Obtain a copy of all of the city commission meeting notes since 25. Gabe first got into office. Check these notes over for all instances of of con trary positions, statements, or actions which were made by Cazares. Turn these over to PR mms.

COLL OFF FLAG

27. Check all court cases against the City of CW or by the City of CW which occurred since the Mayor took office. Take note of any suit in which the Mayor is mentioned as either a plaintiff of or a defendent. Interview the opposing parties to determine if they have any scandal or crime data on Gabe. Also take down appropriate parts of the law suits which involve the Mayor. Check with Leg. Flag first before interviewing the above parties to insure that this type of action would not jeopardize our legal standings or what type of cover would be best employed during the interviews.

COLL OFF FLAG

28. Check out all firms and companies that Cazares has stock in. Get the names of the Bd. of Dirs. officers, owners etc. Investigate the key terminals in each company to determine what if any enemy connections he has, or wast political background he may have.

COLL OFF FLAG

29. Interview Louis and Florence Hosch in CW re Cazares. These people are reportedly enemies of Cazares, per Picot Floyd.

COLL OFF FLAG

50. Check out Ron Schultz, who is a reported "old line democrat" who thinks that Gabe stabbed him in the back. This data is reportedly in an Al Hutchison Editorial per Picot Fleyd. If it is found that Schultz does hate Cazares then interveiw him to see what he has on Cazares x in the way of crimes or scandal.

51. Check into the Jack Tar Corp., its offrers and the Attys. used in the purchase of the FH. If possible, obtain the lawyers files on the FH purchase to look for leads and connections to Cazares and possibly to other early day attackers.

32; Check out any loans that the City of CW has incurred since Gabe took office. Note whether or not Gabe voted to approve the loan by the city. Then check into the Ed. of Dirs., officers, and owners of each place the city is indebted to.

33. Collect all entheta or controvercial mentions of Cazares in the local press outside of the Scn issue. Compile these in a neat little package for PR and further B-1 use.

34. Draw up a list of all entheta writers, announcers, TV commentator etc. who have spoken out publicly about Scn. Check into the seniors of these people, and add these names to that list. Look for common meeting grounds of any of these people with Cazares. Then turn over this list to Leg. to get answered whether or not Gabe ever spoke to any of these people privately on Scn.

35. Interview Karlean DeBlaker re; Cazeres. This should be with an overt cover as Freedom, and should be in conjunction with FR if possible.

COLL OFF FLAG

35. Check out the Gabe Cazares in Whittier, California who appeared in the NCIC bank as being connected to Aliotto and the trucking firm to determine if he is connected at all to Gabe Cazares in CW.

37. Interview Edmond Dillon at the court house for data he may have on the Clearwater Neighbors Inc. and Cazares re. CW Heighbors.

FB. Interview Noel LeCher of Belleaire Fabrics who is a Young Republican, and a reported enemy of Cazares. Find out what he knows on Cazares.
