Brainwashing manual aims at 'freeing' cult members

A DO-IT-YOURSELF manual detailing methods of brainwashing to free members of religious cults has been sent to the Victorian Chief Secretary's Department.

The manual, which describes methods of getting "fringe cult" members of groups such as the Children of God back to "rationality" by sleep withdrawal, starvation, physical exertion, verbal stress techniques and sexual abuse is being circulated in Melbourne.

The nine-page manual was sent to the Victorian Chief Secretary, Mr Dickie, by a group called the Better Family Relations Association, an organisation of social workers and academics set up to resolve religious conflicts within families.

A spokesman for the association, Mr David Ainsworth, claimed yesterday that some of the brainwashing methods described in the book may have been used on cult members in Victoria and that "de-programming" had been associated with kidnapping, violence and court cases in France, Japan, America and Britain.

The booklet is published by an English organisation called People's Organized Workshop against Ersatz Religion (Power) and is based on material published in America by the Citizens Freedom Foundation.

Some of the American material has been sent to sympathetic groups in Victoria with a covering letter calling for "discretion in giving out this information to prevent the cults from developing a counter-action".

The manual, de-programming, the Constructive Destruction of Belief, suggests that parents of cult members be briefed in ruses to kidnap their children from the groups and put them in the hands of a "de-programmer," or "technician."

The reason is "the dread police have of becoming involved in domestic disputes."

EXHAUSTION STAGE

When the member falls into the hands of the de-programmer, this man should have with him "an assistant of a stable nature and very fit, ideally with a background as a former policeman, prison warden, male nurse (mental) or a cult member."

The initial stage of the de-programming is to physically and mentally exhaust the subject until he "can be likened to a new-born child needing only love and education to mould its personality."

This is done through the withdrawal of food and sleep. The booklet suggests physical discipline, like rubbing with ice cubes to keep the subject from falling asleep, or, if he does fall asleep, "throwing
