Hubbard Identified As Native

Was Born In Campbell Hospital In 1911

There have been several answers to the query about L. Ron Hubbard which appeared in last week's Citizen. Mrs. Frank Bassett is the source of most of our information and help was also given by Mrs. C. C. Scott, Mrs. P. E. Danes of Waterloo, Iowa, and Mrs. Fritz Von Seggern of Pasco, Wash. Letters written by Mrs. Danes and Mrs. Von Seggern appear elsewhere in the Citizen.

According to our informants, L. Ron Hubbard was born in March, 1911, at Dr. Campbell's hospital which was located in the residence now occupied by the Donald Dempster family on Oak Street in Tilden. His parents are Mr. and Mrs. Harry R. Hubbard, the latter being Miss Mae Waterbury before her marriage. She is a daughter of Mr. and Mrs. L. O. Waterbury, and is a cousin of Frank Bassett of Tilden.

Mrs. Hubbard left Tilden with her parents and was engaged in some kind of government work and might have met and married her husband during this time. The Waterbury family resided in Oklahoma and Montana after leaving here.

Mr. Hubbard was evidently in the navy at the time L. Ron was born as his mother came back to Tilden for the blessed event and later joined her husband who was stationed in California. Mr. and Mrs. Hubbard now reside in Bremerton, Wash.

According to Mrs. Scott, Wesley Newhall, a former Tildenite, served in the navy under Lieut. Commander Harry Hubbard.

Now that it is known that the originator of the "Dianetics" way of living is a native of Tilden, perhaps townspeople will want to adopt this new philosophy.

Boilermaker Loses Court Relief Plea

After listening to testimony and arguments for more than a week, Circuit Judge Earl C. Latture of Oregon City, sitting here, late Wednesday dismissed the suit brought by Vez J. Hilliard of Gresham to enjoin the Portland Boilermakers' union and its governing board from refusing to assign him for work at the Albina Engine & Machine works conversion dock. Hilliard's attorney indicated the case will be appealed to the supreme court.

"I am of the opinion that the plaintiff's constitutional rights have not been invaded and that any grievance he had he should have placed before the union, where ample machinery was furnished for him to air the same," the judge said.

There are surmises and inferences of arbitrariness on the part of the officers of the union, but there is no evidence that would convince the court to a probability that the defendants are guilty of misconduct. Keeping in mind that we have a war, that we have ships to build, that there is a shortage of men to build the ships, and that these men are at the yards, and that the business is an agent of the union is the one best constituted under the setup to distribute such men.

Judge Latture pointed out that because of the nature on the part of some workmen to leave essential war jobs in quest of higher wages, which has caused a disruption in war production, there was organized a voluntary stabilization appeal board. One of the functions of this board, he said, was to hear appeals of the employees who were denied the right by their employers to have their jobs. The practice would become so flagrant that Paul McNutt recently issued an order freezing labor, the court said.

In the case at bar the plaintiff Hilliard, an representative of his employer, the Albina Engine & Machine works, that he is unable to continue work on their crane on account of working conditions injurious to his health, obtained from his company his release. The judge said he immediately went to the union and asked to be cleared back to the same employer in work at the dock, which work paid an enhanced wage over that

which he had received on the crane. The union declined this request, but offered him a clearance to any other of the shipyards in the area. This suit then was instituted to compel the union to send him to the job of his choice.



The corporation failed to extend its existence in the time and manner prescribed by law and consequently was dissolved on August 11, 1949 due to the limitation of its charter.

CAPITAL CITY COAL COMPANY was incorporated under the laws of Montana on December 16, 1916 for a term of 40 years with the principal place of business in Helena, Montana. This, too, is the only document on file for the corporation. It was dissolved on December 16, 1956 due to the limitation of its charter.

I am required to collect all fees in advance. I can furnish you with a copy of the Articles of Incorporation for \$2.00 for each corporation. If you wish to have a certified copy of the Articles of Incorporation showing that they are full, true and correct as on file in this office include an additional \$2.00 for each corporation. When submitting your remittance please repeat your request.

Dear Mr. Shannon:

Probably the best bet to locate the ranching operation of LaFayette O. Waterbury is to check with the following office: Bureau of Land Management, 222 North 32nd Street, Box 30157, Billings, Montana (59107). This office holds many of the original homestead records and most of the plat maps for Montana; the office also has some sort of index file for homesteaders/filers, in which Waterbury might show up.

Unfortunately our files show no such Waterbury. There is a chance that we could pick up his ranching operation and determine something of its size, if we knew in what area he was located. Without that information, it is impossible to run him down--as there are just too many subdivision possibilities in the large collection of city/county histories we hold.

I did run the name through the 1900 federal census index for Montana, but with no luck. The only LaFayette is a "Woodring," and the only Waterbury with an L--- first name is "Lee" (please see the enclosed copy).

One other lead might be of interest to you in the future: the Montana State Health Dept. holds many death certificates of persons who died in Montana; it is best after 1910, but holds some certificates prior to that. The cost per search and certified copy is \$2.00. You must provide the year of death (more specific dates, if possible) and the full name, as well the place of death (if possible).

Hope this information helps.







Since Eagle records are maintained by the Registration Service, Dick Pryce has referred to me your inquiry of April 7 concerning the youngest Eagle Scout.

Our Eagle records date back to 1912. We have checked them from that year through 1935. There is no "Lafayette Ronald Hubbard" listed, but we did find an entry for a Ronald Hubbard in 1924, in the Eastern part of the country.

Even though this may be the "Ronald Hubbard" who is the subject of your letter, we have no way of telling whether he was the "youngest Eagle Scout in the history of BSA."

We have never attempted to keep this type of record because it is such a controversial sort of thing, and it is our belief that it has no particular value.

We are always concerned that this type of information could lead to a race as to who can achieve the award quickest without regard to preparing properly for the award. - We are more interested in what the young man has learned in his progress to Eagle rank and use he makes of this knowledge in his Troop activities.

In reply to your letter requesting information about Lafayette Ronald Hubbard and his "adoption" as a blood brother of the Blackfeet Tribe, this office has no record of such an action. The Blackfeet Tribe has in the past "adopted" many non-Indians and given them Blackfeet names, but these actions are ceremonial and such people are not members of the Blackfeet Tribe. Perhaps Mr. Hubbard was one of those people. The Tribal office has no records dating back that far and so we are unable to verify that Mr. Hubbard was in fact "adopted" as a blood brother.

Your attention is directed to Mr. Lamb's reply dated September 27 (copy enclosed) which stated Mr. Hubbard's passport number. You were then advised that additional information cannot be released in the absence of a notarized statement of authorization from Mr. Hubbard or a court order from a court of competent jurisdiction. Identical documentation will be required before passport information regarding Mr. Lafayette Ronald Hubbard, Jr., can be released. If he is deceased, however, information may be released provided evidence of his death, such as an obituary, a public notice, or a copy of his death record, is submitted.

Replying to your inquiry concerning our representation in Cuba today, we are represented by the United States Interests Section which is located in the Embassy of Switzerland, Calcado entre L and M, Vedado Section, Havana, 329700. We do not have information concerning a legal attache in Cuba during the period 1949-1952.

In reference to your question concerning a passport requirement to travel to China, Tibet, India, etc., in 1925, a United States citizen was not required to bear a valid passport to enter or leave the United States

between 1922 and 1941. Many citizens, however, did obtain United States passports to comply with a foreign government requirement that entering aliens bear a valid passport. We have been unable to ascertain whether or not those countries in which you are interested required passports of foreigners in 1925.

I hope that the information that we have been able to provide will be helpful.

I refer to your inquiry of August 25 concerning information from the passport file of Lafayette Ronald Hubbard.

Our records indicate that Mr. Hubbard was issued Passport No. Z1889248 on April 23, 1974. Pursuant to the Freedom of Information Act, 5 USC 552(b)(6), we can release no other information without a notarized statement of authorization from Mr. Hubbard or a court order from a court of competent jurisdiction. To do so would be a clearly unwarranted invasion of Mr. Hubbard's personal privacy. The information may be released if Mr. Hubbard is no longer living; however, it will be necessary to provide us with a copy of his death certificate.

If you consider this reply a denial of information, you may appeal our decision to the Council on Classification Policy of the Department of State pursuant to Section 6.8 of Part 6 of Title 22 of the Code of Federal Regulations, a copy of which is enclosed for your convenience.
